

## Announcement of Organizational Changes and Personnel Changes of the Mitsubishi Chemical Group


1. Organizational Changes of the Mitsubishi Chemical Group (Effective as of April 1, 2025)

The Mitsubishi Chemical Group (the 'Group') has decided to shift to a structure where Mitsubishi Chemical Group Corporation will be responsible for formulating the Group's overall strategy, optimizing the allocation of management resources and supervising business management as a holding company, while the operating companies under its control will be responsible for their own business management.

From April 2022, the Group aimed to operate as one virtual company ('One Company, One Team'), and Mitsubishi Chemical Corporation and Mitsubishi Tanabe Pharma Corporation, as wholly-owned subsidiaries, operated in an integrated manner without their own CEOs and executive officers. However, this approach led to issues such as the hampering of autonomy in business operations, including within their affiliated group companies.

Under this new management structure, the Group will promote the appropriate delegation of authority and responsibility to operating companies and their affiliated group companies, in order to provide opportunities for employees on the business frontlines to take on challenges and maximize their performance.


- 2. Chart of Corporate Executive Officers and Executive Officers (Effective as of April 1, 2025)
